

## STYROFOAM RECYCLING VOLUNTEERS HARD AT WORK

Recently, I've had the opportunity to help organize the Styrofoam recyling program and the volunteers who keep it running. The Defenders has three sheds in McHenry County where the public can drop off hard, clean Styrofoam: Algonquin Township Road District, 3702 Northwest Highway, Crystal Lake; Woodstock Public Works Administration facility, 326 Washington Street; and Algonquin Public Works facility, 110 Meyer Drive, Algonquin.

The time and effort our volunteers provide is amazing. We have two groups, although many of our "helpers" work in both groups. One, known as the "sorters/baggers," goes to the sheds and sorts the material, which means separating the "clean" Styrofoam that can be recycled and sold, from the stuff that is not clean, or not the hard, white (or colored) Styrofoam and cannot be recycled and sold. The "clean" stuff gets put in huge plastic bags. (See what we accept below and what we don't accept on the next page.)

The other group is our drivers. One day each week these volunteers go to the U-Haul in either Crystal Lake or Woodstock, and rent a 26-foot truck. From there, they visit each of our three shed sites, pick up the filled bags and transport them to Chicago Logistic Service, the trucking company owned by our board member, Ken Santowski. Ken has a densifier, and one of our volunteers, Gary Johnson (see below) and one of Ken's employees push the Styrofoam into the densifier, which turns the Styrofoam into 4-ft.long logs. Those logs are then available for sale (see on next page).

The Waste Reduction Team has worked diligently in the past year to find grants to help fund our projects, and we obtained three. Our first was given to us by EcoProducts. EcoProducts has been a great partner and support for the team- first, as keynote speaker for our Sustainability Summit and now with monetary donation. We couldn't have started our Race to Reduce Waste Initiative without them. They provided us funds to provide composting for restaurants at a reduced cost and consulted with restaurants on compostable packaging alternatives. If you meet Jamie or anyone else from Eco Products please thank them for their continuous support!

We are so happy to have funding for our main initiative, but the team has other goals. We want to start a community fridge program. This program would rescue food from going to the landfill and make it available to the under-resourced in our county. We have seen successful programs in Evanston and Chicago and plan to bring it to McHenry County. This project needed funding and we found it through Lake in the Hills' Rotary. They honored us with the Major Difference Maker Grant. This grant will cover the cost and upkeep of the fridges. We have two organizations interested in hosting a fridge and cannot wait to help the environment and community with one fell swoop.

Our good fortune hasn't stopped. I applied for a volunteer grant my employer offers. I work for a large corporation and thought it was a long shot, but I was wrong. CVS has given our team a \$1,000 grant to be used for any project! The team is brainstorming to find the best use of these funds. As rookie grant writers, our team is making great strides. We hope we can keep this momentum and help the environment and community for years to come.




## **MCHENRY COUNTY COMMUNITIES CONTINUE MAYORS MONARCH PLEDGE**

Volunteers bring their own equipment, gas, tools and kayak. All the kayakers, tubers and fishermen who use the Kishwaukee River for recreation owe a debt of gratitude to the dozens of volunteers who helped this year, as well as the hundreds who volunteered the past four years.



On October 1, the hunting season starts, so there is no river access for the rest of the fall and winter. Enjoy the lovely woodsy walk at Woodbine down to the river during those months, as many people do. The address is 860 Woodbine Lane in Marengo.

## 2023 Intern Reports

#### Mills Guanci, Water and Natural Resource Protection Team

I worked as a Defenders' Water and Natural Resources Protection Action Team intern this summer. My fellow intern, Gena, and I worked with Nancy Schietzelt and Cindy Skrukrud. Our responsibilities ranged from restoration workdays to data collection to memorizing the names of butterflies. I loved how engaging our work was and that we were trusted with responsibilities such as identifying species for official lists and submitting data. We did many interesting activities this summer, but I especially enjoyed working with the kids from the Youth and Family Center of McHenry County to upkeep two community pollinator gardens. The kids were all interested and excited to work, and the gardens looked great at the end of the day. I was proud that I could lead and teach children and somewhat shocked that I had so much fun doing it. Another takeaway that I gained from this internship is an aspiration to learn as much as I can about the ecosystems that surround me. Learning the names of each plant and bug has taught me a new appreciation for the individuals that make up a prairie, and I feel a stronger sense of connection with both the Earth and the people around me.



#### Gena Denkov, Water and Natural Resource Protection Team

My summer was an eventful one as an Environmental Defenders' Water and Natural Resources Protection Action Team intern. I worked primarily alongside my fellow intern Mills Guanci and my wonderful mentors Cindy Skrukrud and Nancy Schietzelt. We went on many adventures to sites within and around McHenry County. My favorites being Boloria Meadows, the County Administration building and the several sites in Bull Valley where we collected water samples. At Boloria Meadows, we were led by Pete Jackson and Dennis Dreher, the site steward who had been maintaining his beautiful restored prairie for years now. Dennis explained the history of the site and the progress of his restoration throughout the years. At the site, we identified at least ten species of butterflies including my favorite, the Monarch. Later in the week we were then tasked to give pollinator tours at the same site to attendees of the Pollinator Talk and Trek. I was eager to tell and show individuals about the butterflies and the pollinator plants that they rely on. I was so excited to hear of attendees who are avid gardeners and planters of the milkweed plant. We also collected seep water samples from sites in the county. It was an amazing opportunity to be a part of a twenty-year-long study and analyze the health of McHenry County's seeps. At the County Administration building we were tasked with preparing the soil and the planting of natives on parking lot islands. It was tough work at first, as it was only Scott Kuykendall, Mills, and I loosening the hard, dry soil, but on planting day our efforts were proven worthy as so many volunteers gathered to plant hundreds of plants in just a few hours! I think everyone there could agree that it was so rewarding. Not only did I learn so much this summer, but I hope that I shared some of my knowledge at the several outreach events we either hosted or visited. I had an amazing summer with the Defenders. Thank you to everyone who helped me along the way.

#### Emma Kropke, Waste Reduction Team

This past summer I worked under the Waste Reduction Action Team with co-chairs Cecila Carman and Michelle Muryn. One of our main focuses was establishing a location for a community fridge in McHenry County. Food waste is a significant issue, and the community fridge would serve as a way to mitigate waste while helping provide food for those in need. I contributed with outreach and connecting us with local contacts who helped us move forward with the project. We secured a grant for the project, and received location permission from the Youth & Family Center of McHenry County. Additionally, we found a place for a new compost bin at one of the pollinator gardens in McHenry County. I also researched the effects of plastic and Styrofoam on the environment and human health, which I presented at the McHenry County Fair. Not to mention, the Environmental Defender's signage we posted around the fairgrounds as a way to encourage people to reduce their own waste. I really enjoyed my time with the Defenders and it gave a unique insight into local environmental policy. I connected with representatives from Evanston, Lake County, the Crystal Lake Wastewater Treatment Plant, and the Illinois state representative for International Compost Awareness Week. Thanks to Cecilia and Michelle, I had the privilege to learn from these amazing people, and I cannot thank them enough!

Jon Cian Gross, Waste Reduction Team

During my summer internship with the Defenders' Waste Reduction Action Team, I worked on multiple projects that gave me real-world experience in sustainability. My main interest was in microplastic concentrations in McHenry County's rivers. I took samples from the Kishwaukee and Nippersink Rivers (left), which are on their way to UIUC to be analyzed as a follow-up to a study done in 2020 which studied the effect of water treatment on microplastics in rivers. These efforts will hopefully bring awareness and insight to local plastic pollution. In addition to this, I worked to set up a thrifting and textile recycling event with Home of the Sparrow in Woodstock. While I was not able to complete this before leaving for college, I hopefully secured the event for the Defenders in the future. In addition, I helped develop posters and marketing for a more sustainable McHenry County Fair and develop plans for a future single-use plastic ban. I am more than grateful for the chance to develop my interests in sustainability and meet so many great people.



The MCSEEP conference room is ready for use by all Defenders' teams and associated organizations. In addition, I received some materials from Pat Dieckhoff, the first director of MCSEEP - although at the time, the organization was called the McHenry County Schools Recycling Education Program. Over the summer we met several times with schools that have all-year Pre-K classes. We also provided games for the County Fair and the Monarch Festival in Crystal Lake. ## PADDLING THE NEW NATIONAL RECREATION TRAIL - THE FOX RIVER

On a beautiful Saturday morning, August 12th, nineteen of us took to the Fox River for the annual Fox River Paddle with a 10AM departure from Cornish Park, Algonquin. The nine-mile stretch to Voyageur Landing in Elgin is an all-day event with time to learn about the river and its natural and human history along the way. While we had hoped that the Carpentersville dam would have been removed by now, that wasn't the case, so a long single-line of boats emerged one-by-one from the river at portage. Perhaps THIS will be the last time we'll need to drag our boats up and over. But, this is always a great place to feature a speaker, with last year's being Gary Swick, President of Friends of the Fox River. This year we were very fortunate to have another very special Fox River advocate.



Our group was joined by Karen Ann Miller, Executive Planner with the Kane County Development Department and Illinois Co-Chair of the Fabulous Fox! Water Trail. If this name sounds familiar to the reader, it should! Karen has been spearheading the effort for the Fox to become a National Water Trail for many years, along with partner organizations and volunteer advocates. She has addressed many groups in the past and was a featured speaker at It's Our River Day in Algonquin several years ago, as well as a panelist at the most recent Fox River Summit. It was a celebratory moment when Karen talked about the June 3rd, 2023 designation of the Fox River as a National Recreation Trail by the United States Department of the Interior! With maps in hand for everyone, she shared how this came to be and the plans ahead that will support and revive not only the river, but the river towns along the trail. This designation puts the Fox on the map within the National Park Service. This year, our group was followed briefly by a drone, part of the gathering of new marketing material for the Fabulous Fox! Water Trail. I wonder what fame next year will bring!

With a short paddle after portage to lunch, we again disembarked, and this time scrambled up the riverbank for a long lunch at Rosie O'Hares in East Dundee. With outdoor seating located right across River Road from the Fox, it's a perfect spot to relax, have some good food and support local. With still a few miles to paddle after lunch, the group - full and happy - completed the journey at 5PM.

For the past few years, we've been working with Paddle On! Outfitters to bring this opportunity to float the Fox to those who may not have a boat, and to assist with the sometimes-complicated work of shuttling boats and people between take-out and put-in. With rental and shuttle included, or just the shuttle if paddlers have their own crafts, it's a great way to organize things, especially with a big group. A big thank you to the Village of Algonquin for supporting the mobile outfitter model with put-in at Cornish Park and to Matthew Capes, owner of Paddle On! Outfitters, Inc. not only runs the shuttle, but they create the event through their Facebook page, which has helped enormously in increasing the number of paddlers on this annual trip. Congress passed the Inflation Reduction Act! You called, emailed, wrote letters and Tweeted for months. And Congress PASSED THE BILL. Now the Inflation Reduction Act, which includes the biggest climate provisions in US History, will become law. Thank your Senators for their support! Trees help people feel better. Citizens Climate Lobby actively supports urban forestry and tree canopy building efforts. Trees lower air temperatures and humidity, and they can influence wind speed. Evaporation of water from trees, or transpiration, has a cooling effect – trees have been shown to reduce asphalt temperatures by 35 degrees Fahrenheit. Trees also improve air and water quality, reduce flooding and erosion, and create habitat for plants and animals. We need to plant trees where needed, ensure diversity of trees and protect the mature tree canopies in place. The McHenry County CCL Chapter has a Tree Initiative Task Force and is actively recruiting new members – please consider joining us!

One of CCL's recent calls to action has been to tell Congress to pass the PROVE IT Act. It's a bipartisan bill introduced in the Senate that would take the first step toward establishing a U.S. carbon border adjustment mechanism, or CBAM. A CBAM would level the playing field by calculating the carbon intensity of certain domestic and foreign products, and then imposing a carbon fee on the extra carbon footprint of products imported into the U.S. The CBAM could also refund domestic products for their lower carbon footprint when they're exported across our border, so they can better compete in other countries' markets.
